


1. Whereas vide letter No: PS/MD/6668-94 Dated; 10.12.2014, the tentative seniority list of Corporation borne Engineers has been circulated.
2. Whereas, since the issuance of tentative seniority list various officials have retired whose names were required to be deleted.
3. Whereas during since 2017 various promotions/ change of designations were affected and as such the seniority list previously issued needs updating.
4. Whereas the committee constituted vide order No:132 of 2023 dated:20-02-2023 have deliberated on the issue and the additions as suggested by the committee have been incorporated in the fresh tentative seniority lists after some information obtained from the concerned DDOs (AO (K/J) and incorporation of grades/pay scales as per sanctioned strength duly recommended by the Establishment Sub-Committee of the corporation constituted vide Govt order No. 64-PW(R&B) of 2016 dated:29.02.2016 and then followed by the confirmation by the Board of Directors (JKPC BODs) in its 91<sup>st</sup> meeting held on 27.06.2016.

Now therefore a fresh tentative Seniority list of Corporation borne employees (Engineering) has been framed and is circulated for general information of the employees concerned for filing objections (if any) through respective Dy. General Managers /Accounts officers (J/K), J&K PCC Limited Jammu/Srinagar.


